☐ Scholarship must be applied toward tuition fees.

- o H and his spouse, W, reside in South Dakota
 - H is retired from farming
 - W is in poor health and wishes to donate some of her estate to the American Cancer Society, as they have been a huge help in her diagnosis.
- o H and W are married with three adult children: A, B, and C
 - Child A resides in Minnesota and has a gambling addiction,
 - Child B resides in Minnesota with their spouse and their minor child. This child, H's grandchild, has special needs.
 - Child C resides in California.
- H and W sold their South Dakota ranch for a profit of \$30,000,000.00 in April of 2023 and wish to remain in South Dakota for the remainder of their lives. The profit from the sale accounts for one-third of their current estate. They wish to keep their assets within South Dakota while providing for their children.
- O H has come to you wanting to know which estate planning vehicle(s) would work for their estate in order to provide for H and W for the remainder of each of their lives. After both H and W have passed, H wishes to provide for A, B, and C with remainder going to grandchildren. H is particularly concerned about GSTT/Estate Tax issues and ensuring his heirs are cared for but not given money to squander.
